



### LE HAVRE FRANCE

1 ancient landfill, 400 000 tons of waste, eroding by 2 m per year into the channel: **Surfrider asks for complete excavation.**



### BRETIGNOLLES-SUR-MER FRANCE

Pleasure port proposal in fragile ecosystem and waves, flood risk and waves disappear: **Surfrider asks to preserve the coastal zone, for all users.**



### ST-JEAN-DE-LUZ FRANCE

Surfpark proposal by Boardriders, only 1.5km's from perfect natural waves: **Surfrider prevented development and proposes alternatives.**



### PORTO PORTUGAL

Eye and ear infections from severe pollution, harbor extension proposed, no waves no clean water: **Surfrider asks local governments and the EU to protect our playground.**



### DOUGHMORE IRELAND

US President Donald Trump's hotel company, Trump International Golf Links (TIGL), seek to build a massively controversial seawall on a public beach to protect his Trump Golf Resort in western Ireland. **Surfrider asks for the withdrawal of this project.**



### KNOKKE-HEIST BELGIUM

Test-island proposal for coastal protection and shipping corridor, top-down government decision not taking into account recreation on the north sea: **Surfrider asks for responsible alternatives.**



### TARRAGONA SPAIN

Massive plastic pellet spill by industry in 2018, still occurring daily at La Penida beach: **Surfrider investigates with local partner and lobbies at EU level.**



### MARTIGUES FRANCE

The company Kem One spilled 6 hectares of iron chloride, in a pristine environment: **Surfrider takes legal action to prevent such spills in the future.**
